### MANAGER MUSINGS

There is a saying that I like to use when there is construction or things are a little crazy for a while -SHORT TERM PAIN = LONG TERM GAIN! . This applies to a lot of things going on in Tri-Par right now.

Some items taking place in the past month:

- All sewers were cleaned out and camera-ed to see if there are any pipe collapses or obstructions in the system
- The smoke testing project from 2019 is being followed up on by the County to ensure that sewer water is not entering the storm drains. To put it in layman's terms; the storm water generally drains right to the bay, river, and/or ocean. It is generally untreated as it just falls from the sky. If contaminated water from a toilet gets in there then bad things can happen such as beach closings, high e-coli readings, and red tide. The County is under a Federal Clean Water order to get this cleaned up ASAP, so that is why you may see heightened effort to get this project completed. Please do your best to co-operate.
- We have had a lot of water main breaks recently as the supply pipes in some sections are getting on in years. The county has worked hard to isolate the system so as to inconvenience as few people as possible when a break occurs.
- FPL has been working on our lights in the park and in the Parking lot of the clubhouse. The new LED's are brighter, last longer, and are cheaper to run.
- Updates of Tri-Par Policies & Procedures are ongoing, we just finished a big overhaul of the Fines & Suspensions Section, more to come!
- The contractor building the Car Condo's is in the home stretch of finishing the buildings. Check out the new sidewalk along Desoto and into Tri-Par by the new building.

So, lots going on in infra-structure improvements here in Tri-Par. This is really a good thing for us in the long run! And that's the way we need to look at it- Short term pain=Long Term Gain!

- Be mindful that Tri-Par will still issue violations if your lawn is not in good shape regardless of who is taking care of it! We want Tri-Par to look good all the time!

# MEET DALE FUNKHOUSER

Not only does Dale live in a mobile park here at Tri-Par he owns a mobile park in Pennsylvania! The park in Pennsylvania is 140 acres

and started out as a joint venture with a partner, but Dale eventually bought out the partner and now owns the park solely. Dale met his wife Betty at that park and was her insurance agent as well. The whole time Dale was an insurance agent he continued to manage the mobile home park until he retired in 2012, when he sold the agency.

Dale visited a cousin who lived in Tri-Par. That is how he and Betty became acquainted with Tri-Par and decided that this would be a place in which they would like to winter. In 2014 the Funkhouser's rented and in 2016 they purchased the home at 5226 Tri Par Drive. Knowing about the management of a mobile park, Dale immediately began attending board meetings and has been able to refine his speeches to the three minutes limit that the board allows him.

Born in Meadville, Pennsylvania, Dale grew up in Espyville, graduated from Conneaut High School, and today he and Betty have a home in Linesville, PA. All these places are within 15 miles of each other, in the upper north western part of Pennsylvania, 50 miles south of Erie, PA, and 100 miles north of Pittsburgh. Growing up in a working class family, Dale began picking potatoes at age six or seven, sold strawberries, had a lawn mowing service, lined at a bowling alley, and managed a concession stand at Pymatuning Lake. Right out of high school Dale was going to attend a technical institute but changed his mind at the last minute and went to work for a warehouse. The next job was a driver/salesman for Continental Baking Company (i.e. Wonder Bread), and then when he turned 21

he had the opportunity to sell life insurance, being employed by American General Life. Five years later he resigned his position and opened his own independent insurance agency. Dale was self-taught and became licensed to sell securities and do financial services. He sold the business in 2012, after 39 years of working. During the time that he worked, Dale and Betty were able to travel, called incentive travel, where the insurance business required him to go to other places, including Europe.

Dale and Betty have been married for 32 years, raising two children, 7 grandchildren, and two great grandchildren, all of which live near their northern home. They shared a 21 foot ski boat to go boating and skiing with since they lived so close to Conneaut Lake. Betty's job was a press operator, which she worked at for 20 years. How special it is to have them here at Tri-Par where you can see Dale at the board meetings and Betty walking or biking around the Park.





### FROM THE PASTOR'S LAPTOP

### "Give Thanks"



November and Thanksgiving. They seem to go together not only on the calendar but also in our minds. If you say it is November, my mind always jumps to, "Oh my, Thanksgiving is almost here." At our age (I am assuming that we are in the same age category of 55+), we have celebrated a number of Thanksgiving Days. Some of them are memorable but probably many of them have blended together into a few common experiences...turkey, gathering with family/friends, eating too much and possibly leftovers for days.

All this is good but the main point of Thanksgiving is to give thanks. That is not always easy to do because sometimes life is a struggle. There is no question that life includes the joyous moments and the sad moments. That brings me to Thanksgiving 2020. For our generation, we have been experiencing one of the most stressful times of our lives. You know what I am talking about...coronavirus, social distancing, change of lifestyle, racial tension, violence and political turmoil.

So how do we give thanks during this season of our lives? 1 Thessalonians 5:18a (NLT) says, "Be thankful in all circumstances." I believe this is possible. Not easy, but possible. Without being too simplistic, it is a choice and a choice of attitude. If we allow circumstances and situations to dictate our attitude of thanksgiving, we have given up our God given ability to choose how we live our lives. So, it must be possible to be thankful at all times. So how do we do this? A couple of suggestions:

- Don't hold onto your struggles too tightly. Someone suggested to me that when we have a struggle or hurt that we should hold it in an open hand. We have to hold it because it is our struggle. But if we hold it in a clinched hand, we can never allow ourselves to slowly release it to God. So, it is not "letting go of it and forgetting it." It is holding it with an open hand.
- 2. Keep a "Thanksgiving Journal." Make a daily list of the things that you are thankful for. Record it on your list throughout the day. Include every small and big thing. It could be a bird singing outside your window, having hot water for a shower, a chair to sit in, a bed to sleep in, etc. Then, before you go to sleep, look over your list and recall all the things that bring you thanksgiving.
- 3. Everything that seems negative or bad, ask yourself where is God in this? God is good and there is always

good if we look for it. For instance, I can bemoan my health because it is not as good as when I was 25 years old or I can be thankful that I still am able to get out of bed every morning. I can grumble that I cannot afford a more expensive car or I can be thankful that I still have a car that gets me around when I need it. Be sure to record these "thanks" in your "Thanksgiving Journal."

So, it is a choice. It is a choice that every one of us can make. Give thanks this Thanksgiving for all the good in your life.

### UNITED STATES FLAG CODE

These reminders give a summary of some of the Do's and Don'ts for flying our flag.

When displaying the flag, DO the following:

- Display the U.S. flag from sunrise to sunset on buildings and stationary flagstaffs in the open. When a patriotic effect is desired the flag may be displayed 24hours a day if properly illuminated during the hours of darkness.
- When placed on a single staff or lanyard, place the U.S.
   Flag above all other flags.
- When flags are displayed in a row, the U.S. flag goes to the observer's left. Flags of other nations are flown at same height. State and local flags are traditionally flown lower.
- When used during a marching ceremony or parade with other flags, the U.S. Flag will be to the observer's left.
- On special days, the flag may be flown at half-staff. On Memorial Day it is flown at half-staff until noon and then raised.
- When placed on a podium the flag should be placed on the speaker's right or the staging area. Other flags should be placed to the left.

### When saluting the flag DO the following:

- All persons present in uniform (military, police, fire, etc.) should render the military salute. Members of the armed forces and veterans who are present but not in uniform may render the military salute.
- All other person's present should face the flag and stand at attention with their right hand over the heart, or if applicable, remove their headdress with their right hand and hold it at the left.

### Quick list of Flag Etiquette Don'ts:

- Don't dip the U.S. Flag for any person, flag, or vessel.
- Don't let the flag touch the ground.
- Don't fly flag upside down unless in emergency.
- Don't carry the flag flat or carry things in it.
- Don't use the flag as clothing.
- Don't store the flag where it can get dirty.
- Don't use it as a cover.
- Don't fasten it or tie it back. Always allow it to fall free.
- Don't draw on, or otherwise mark the flag.
- Don't use the flag for decoration. Use bunting with the blue on top, then white, then red.

### State Laws

### Florida Golf Cart Laws

A golf cart may not be operated on public roads or streets by any person under the age of 14. A golf cart may be operated only during the hours between sunrise and sunset, unless the responsible governmental entity has determined that a golf cart may be operated during the hours between sunset and sunrise and the golf cart is equipped with headlights, brake lights, turn signals, and a windshield.

### Contracting/Licensed Contractors

Any new structure or improvements to an existing structure must be performed by a State of Florida or locally-registered Sarasota County contractor. Owner-builders can perform work with the applicable permit. To report suspected unlicensed contracting or activity, please call 941-861-5000 or Crime Stoppers at 941-366-TIPS (8477); you may remain anonymous.

### ALERT Sarasota County --- REPLACES Code Red Warning System

### Sarasota County Code Highlights

- Junk, Trash and Debris: Prohibited from being left in the yard and must be disposed of properly. This includes, but is not limited to wood, tires, automobile parts, hazardous waste, abandoned property, unusable or discarded household items, inoperative or discarded machinery or equipment, motor vehicles and trailers, which are inoperative or lack current license tags, solid waste, construction or demolition materials.
- *Unlicensed, Inoperative Vehicles*: All vehicles must be operable and have current license tags or must be stored in a completely enclosed building.
- Overweight Vehicles: Parking, servicing repair and storage of trucks, buses, vans, and tractor trailers in excess of 6,000 pounds vehicle empty weight is prohibited in residential or open use districts.
- Living in Motor Homes or RVs in Residential Areas: It shall not be used for living, sleeping, housekeeping or business purposes and shall not be hooked to any utilities.
- Building Permits: Before the start of any construction or structural repair, check with the County permitting Office (861-6678) to ensure if a permit is required.
- Household Garbage and Yard Waste: All waste must be in trash cans, plastic bags or tied bundles, weighing no
  more than 40 pounds. Put containers out no sooner than 5 pm on the day before pickup (Sunday) and remove
  them by 10 am the day after (Tuesday). All containers are to be stored inside or rear yards only. You must separate
  yard waste from solid waste.
- Household Hazardous Waste: Except for motor oil and filters, hazardous waste is not collected at the curb. You
  must bring these types of items to a collection center, neighborhood collection or community collection program
  for proper disposal.
- Appliances: Residents may call Waste Management at 493-4100 to schedule a pick-up for an appliance or an
  electronic item. Refrigerator and freezer doors must be removed before placing at curb. Request for pick-ups
  must be made 48 hours prior to your regular collection day. This service is included at no additional cost (item
  limits may apply).

Call the Sarasota Call Center (all violations) at 941-861-5000 or Code Enforcement at 941-861-6403 to report a violation of these codes.

### Recycling

We are all aware of the need to cut down on our trash and the impact it has on our environment. Some activities you can undertake to reduce the impact of the waste you produce:

- Waste Prevention. Avoid buying more than you need. Print only documents and emails that must be legally stored in paper form.
- Waste Reduction: Avoid products with excessive packaging. Buy loose vegetables instead off pre-packed goods.
- Reuse: Repurpose plastic bags. Find creative ways to transform used containers into home storage bins.
- Recycle: We are all recycling in our homes, but sometimes find we are attending or running meetings or social events where the building does not have recycling facilities. (Such as our Tri-Par Clubhouse) Club leaders can arrange to have cardboard items, pop cans and steel cans taken home so that these articles can be recycled.

### **Dogs and Cats**

Sarasota County Ordinance Chapter 14 contains the regulations concerning pets and other animals. These regulations contribute to the well-being of the pets in our community and, therefore, to the well-being of us all.

- Each year you must obtain a license certificate and tag for your dog or cat. In order to receive the license, your pet must be vaccinated against rabies by a licensed veterinarian. The official county license may be attached to a collar or harness and must be worn by the dog or cat at all times.
- Your dog or cat may not run at large on any public property or the property of another and must be under the direct control of a responsible person. Direct control always means immediate and continuous physical control of an animal (dog or cat) by means of a fence, leash, cord or chain of sufficient strength to restrain the animal.

- Under no circumstances shall a person improperly tether any animal. It is unlawful to tether an animal outdoors, except when all 10 conditions (listed in Sarasota County Code of Ordinances, Section 14-35) are met. The most important condition is, "The Animal is in visual range of the Owner, and the Owner is located outside with the Animal."
- There have been instances when individuals are frightened by the behavior of our animals. If this occurs to you or you observe anything listed above, please report the incident to Animal Services at 861-9500.

### F.I.S.H.Transportation (Free Medical Transportation)

Free medical transportation (via automobile) for Sarasota residents only. Donations are accepted. Rides available in the Sarasota area only. Transportation is for medical appointments only. MUST call to schedule 48 hours ahead and appointments must be between 9 a.m. and 2:30 p.m. Phone: 941-953-5838

### Tri-Par Policies and Procedures

### Background Check for New Owners, Renters, or Caregivers and Guests Who Stay More Than 30 Days

Background checks are required for all first-time buyers, renters, or caregivers in Tri-Par Estates. A background check is also required for first-time guests staying more than 30 days. Renters, caregivers, and guests who have left the Park for 12 months or more must reapply for a background check. A per person application form and per person \$50.00 fee must be submitted to the Tri-Par Office a minimum of 30 days prior to the desired occupancy date for processing and the Board's action. The new application form is available at the Office.

### Board Approval Is Required Before Moving into Tri-Par

If a renter, buyer, or caregiver moves in without the Board's prior approval, the first action will be to start the process to assess a fine against the owner in accordance with Section 22 of our deed restrictions. Secondly, unapproved renters or owners will be required to vacate the property and leave the park. If they refuse and it becomes necessary for legal action to remove the unapproved occupant(s), the Board of Trustees shall be entitled to recover all costs, including, but not limited to, reasonable attorneys' fees (Section 21 of Deed Restrictions) from the property owner.

### Use of Tri-Par Common Facilities

All visitors under 18 years of age must be accompanied by a parent or adult when using Tri-Par Facilities. No one under 18 is permitted in the Spa or in the Exercise Room. Most of us noticed more guests this year than ever before. It is important that we ensure that our guests are made aware of the rules of the Park.

### Speed Limit in Tri-Par

The speed limit throughout our Park is 20 MPH. We have many walkers, bikers, and people on their golf carts every day. For the safety of all our residents, please do your part in observing the speed limit. When you have guests, let them know we would very much appreciate their maintaining the 20 MPH speed limit within the Park.


