### ITEM 5.05 POOL/SPA/DECK/PATIO RULES AND POLICY

### FOR ALL AREAS OF POOL/SPA/DECK/PATIO (hereinafter PSDP):

- 1. HOURS: 9:00 am to 10:00 pm daily unless otherwise posted or ordered by Board of Trustees.
- 2. Each resident must use their own fob to enter/exit PSDP. Anyone granting access to non-fob holders is subject to deactivation of their fob.
- 3. No smoking or vaping in all areas of PSDP.
- 4. No glass of any kind in all areas of PSDP. Food and plastic beverage containers are allowed in **PATIO AREAS**. No food or beverages other than plastic water bottles are permitted at/on pool deck area.
- 5. No running or horseplay is allowed anywhere in PSDP.
- 6. SERVICE DOGS ARE WELCOME, PER LAW, IN PATIO AREA. NO DOGS IN SWIMMING POOL.
- 7. All persons must vacate the area at first sign of inclement weather.
- **8. ALL PERSONS USE FACILITIES AT THEIR OWN RISK.** Tri-Par does not provide lifeguards and assumes no responsibility for accident, injury, or death to any person using PSDP.
- 9. Violation of rules may result in suspension of privileges and/or penalties. See Policy & Procedure 5.03 and 5.08.
- 10. Tri-Par Estates Park and Recreations provides music on the pool/spa/deck/patio area for residents listening enjoyment, Monday through Saturday between the hours of 11:30 am. to 4:00 p.m. Exceptions are made for Club activities that have live entertainment scheduled on the pool deck (i.e. Fun & Sports patio parties, etc) No other music is allowed to be played during these hours or at live events by residents/guests without the use of earbuds.

### **POOL RULES:**

- 1. A SHOWER is required before entering the Pool or Spa.
- 2. **PROPER BATHING ATTIRE** must be worn in pool. Regular street clothing, shorts, cut-offs, etc. are not permitted in water.
- 3. Goggles only and any Coast Guard approved safety equipment may be used.
- 4. **EXCEPT FOR SPECIAL EVENTS AND SCHEDULED POOL ACTIVITIES**, toys, balls, rafts, inflatables, etc. are NOT permitted in pool. **WATER WINGS ARE NOT ALLOWED AT ANY TIME. NOODLES** are allowed to be used appropriately by residents and guests.
- 5. No diving at any time.
- 6. Laundry or dishes shall not be brought into the shower room for washing.

## **SPA/HOT TUB RULES:**

- 1. SHOWER and PROPER BATHING ATTIRE rules are same as listed above for the Pool.
- 2. Children under 12 must have adult supervision to be allowed entry into the spa/hot tub area.
- 3. A maximum of 10 persons are allowed in spa at one time.
- 4. Pregnant women, small children, people with chronic or acute health problems, people using narcotics, alcohol or drugs that cause drowsiness should not use the spa/hot tub.
- 5. Florida Department of Health, Sarasota County, recommends no person shall remain in spa/hot tub longer than 15 minutes.

### **PATIO RULES:**

- 1. Lounges should be covered with a towel when occupied.
- 2. Cooking inside pool area/deck/patio is prohibited.
- 3. Please do not drag furniture along concrete/pool deck.
- 4. All trash must be deposited in the containers provided.

#### **GUESTS:**

- 1. Residents may use their fob to admit and accompany their guests in PSDP. See Policy and Procedure 5.03 and 5.08.
- 2. A limit of six guests per resident are permitted.
- 3. If guests desire to use PSDP without accompaniment by the resident, the resident must secure a fob for the visitors according to fob policy and procedures 5.03 and 5.08.
- 4. Infants under 2 years of age, any child not fully potty trained, and adults wearing incontinent briefs are not permitted in the pool/spa.
- 5. Adult supervision is required for children under 12 years of age.
